Deposit: 25% of the total (\$_____) is due at the signing of this agreement, 50% of the total (\$_____) is due on the wedding day and the balance (\$ _____) is to be paid upon receipt of the final product.

Overtime: Overtime will be prorated at \$200 per hour

Expenses: The client is responsible for all expensed related to travel, accommodation, meal(s), etc. incurred by the photographer in connection with the wedding. A meal must be supplied for the photographer during the reception. The first hour of travel (50 miles) is free but after the first hour/50 miles there will be a pro-rated charge of \$50 per hour plus \$0.48 per mile traveled.

IMPORTANT: Please provide a written description of any group portraits you desire.

Entire Agreement: This agreement contains the entire understanding between Nicole Martyn Photography and the Client. It supercedes all prior and simultaneous agreements between the parties. The only way to add to or change this agreement is to do so in writing, signed by all parties.

Event guide: Nicole Martyn Photography recommends that the Client designate an "event guide" to point out and gather important individuals to the photographer for informal or candid photographs during the event. The photographer will not be held responsible for not photographing desired subjects if there is no one to assist in identifying and gathering people for photographs. Nicole Martyn Photography is not responsible if key individuals fail to appear or cooperate during photography sessions or for missed images due to details not revealed to Nicole Martyn Photography.

House Rules: The photographer is limited by the guidelines of the ceremony official or reception site management. Client agrees to accept the technical results of their imposition on the photographer. Negotiation with officials for changes to these guidelines is the responsibility of the Client.

Film and Copyrights: Until final payment for services is made, the photographs produced by Nicole Martyn Photography are protected by Federal Copyright Law and may not be reproduced in any manner without written permission of the photographer. Upon final payment by the Client, limited copyright ownership of the images will be transferred to the client under the following conditions:

The negatives, digital images and or slides purchased are the property of the Client for personal use and reproduction and for the purposes of giving the photographs to friends or family.

The client must obtain written permission from and compensate Nicole Martyn Photography prior to the Client or any other party selling the photographs for profit.

Exhibition: Client grants Nicole Martyn Photography permission to display images resulting from this assignment as an example of Nicole Martyn Photography's work or for entrance into photographic competitions. Client further releases all claims to profits that may result from use of images.

Model release: The Client hereby grants Nicole Martyn Photography and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish pictures of the Client, the Client's guest or any other picture taken during the completion of this assignment for for editorial, trade, advertising or any other purpose and in any other manner and medium; to alter the same without restriction; and to copyright the same. The Client hereby releases Nicole Martyn Photography and its legal representatives and assigns from all

claims and liability resulting from said photographs.

Limit of Liability: In the unlikely event that Nicole Martyn Photography is unable to perform the guidelines of this contract due to any cause beyond the control of the parties, or due to the photographer's illness or injury, Nicole Martyn Photography will make every effort to secure a replacement photographer. If the aforementioned situation should occur, and a suitable replacement is not found, responsibility and liability of Nicole Martyn Photography is limited to the return of all payments received for the event package. Nicole Martyn Photography will take the utmost care with respect to exposure, transportation and processing of photographs. However, in the unlikely event that the photographs are lost, stolen or destroyed for reasons within or beyond Nicole Martyn Photography's control, Nicole Martyn Photography's liability is limited to the return of all payments received for the event package. The limit of liability for partial loss of originals shall be a prorated amount based on the percentage of original exposures lost.

Cancellation: In the event of cancellation, the security deposit paid is non-refundable. The client will also compensate Nicole Martyn Photography for any charge related to the event up until the time of cancellation.

Completion Schedule: Development and processing of photographs takes approximately six weeks.
